DID YOU KNOW

Overtime pay for full-time Plant and Transportation employees is to be one and one-half (1 ½) times the regular rate for each hour worked beyond a weekly schedule. Employees are not to be given time off from their regular daily schedule to avoid payment of overtime for working special assignments.

If you are scheduled 35hrs. weekly and you work beyond those scheduled hours, you are entitled to overtime. If you are not being compensated as stated above, please contact your union rep, E-Board member or the President.
