DID YOU KNOW

Longevity Increments shall be paid for only those employees completing the 9th, 12th ,14th & 16th year of employment (during the 12-month period preceding the start of the school fiscal year beginning July 1st) in the amount of the increment listed on the salary schedules. This longevity schedule does not apply to bus drivers or monitors. Bus Drivers shall be paid only for the following increment:

.10cents/hr. for those drivers completing the 16th & 20th years of service. Regular increment for drivers completing the 18th year of service.

Monitors shall be paid only for the following increment: .34cents/hr. for those monitors completing the 9th year of service.

Employees with previous part-time employment will have prior part-time work pro-rated for longevity increment.
