DID YOU KNOW

NYSUT has initiated the Fix Tier Six Campaign. It is unfair for some NYSUT members to work longer and contribute more to earn a significantly reduced pension. Consider this.

Tier 6 members pay 3 to 6

percent into the pension

system their entire career.

Their contributions grow with their pay raises.

Tier 4 members contributions

are capped at 3 percent and

end after 10 years.

Tier 6 members must work

to age 63, up to 40 years of

service, or face heavy penalties.

Tier 4 members can retire at

55 with 30 years of service.

It is important to support this campaign in any way you can. Tier six undervalues our profession. Our work is important. Our pensions should reflect that. Go to FixTier6.org and sign up!
