## **DID YOU KNOW**

Any changes in carriers for health insurance coverage shall be by mutual agreement.

This language is in our contract under Article XV Individual & Family Health Insurance.

It essentially means that unless we agree to change our carrier which is currently Excellus, the District cannot change to another carrier.

This type of language protects us from being forced to have a less than superior carrier, which can in turn force us to have in network providers that do not include your doctors or specialists that you may desire.

Also, did you know that passes for athletic events and recreational swimming are designated for the use of regular, full-time adult employees. An advance notice will be issued by the school authorities canceling passes if recommended seating capacity affecting safety becomes a problem at future home activities.
